Cost Allocation Plan FY 2021-2022

Ariel Ayers presented the FY 21-22 Cost Allocation Plan for Smart Start funding. Jeanne Dixon moved to approve the cost allocation as presented, Second: Rosolena Conroy, all were in favor.

Program Oversight Committee Report:

Ann Benfield presented an update from the Program Oversight Committee. Ann shared we are keeping an eye on Breastfeeding Support because some of their groups have little participation. Program Oversight did OK funding for Breastfeeding Support and Reach Out and Read due to their rankings, but did note there could be a reduction in funding because of flat funding of Smart Start. Ann also went over the EC Profile and discussed each criteria.

Executive Committee Report:

Ann Benfield did give a report from the Executive Committee and reported they did reallocate funds at their last meeting. The committee also: discussed the CCM Strategic Plan because they are focusing on 0-5 year olds and early education, reports on the Governance and Development Committee work, NCPK Summer Program, and they committee did approve a private donation to the Smart Start Advocacy group.

Development Committee Report:

Ann Benfield reported that the development committee met two times in May and discussed the Pigeon Race and the Coming Together for Children Luncheon. The committee has decided to focus the board's attention on the Coming Together for Children Luncheon instead of the Pigeon Races, because the Surry County Rotary is not sponsoring it this year so we can observe.

The committee is also exploring a project to provide "Duffle Bags of Hope" for child 12 - 18 years in the foster care system. The committee needs to meet to discuss the plans for the future.

2020 Cabarrus County Community Needs Assessment

Ann Benfield shared the 2020 Cabarrus County Community Needs Assessment with all board members by email and hoped that all would read and review. The top three community needs for the next 5 years will be: Homelessness, Mental Health and Early Education/Child Care.

Rowan Cabarrus Community College (RCCC) State Audit Report

Ann Benfield shared a summary of the State RCCC Audit Report and reported the Partnership has been monitoring very closely all Smart Start funds with the Grant Specialist at RCCC. We have not had any issues with compliance. Steve Morris and Jeanne Dixon reported the Board of Trustees took all issues very seriously and RCCC is correcting and hiring a new CFO at the college.

Office Opening

Ann Benfield reported the office opened from 8:30 – 4:30 daily on May 1st, and Lyne and Lissy are working full time in the office. Karen Calhoun reported today the outer door of the Department of Human Services will be opened July 1st daily from 8:00 - 5:00 pm.
