DENTAL CARE INFORMATION FROM THE CHA DENTAL CLINIC

- 1. Screenings for NC Pre-K have to be done by a dentist we offer them for free at both of our fixed sites as well as comprehensive care for all kids, regardless of insurance.
- 2. Medicaid, private insurance, and uninsured patients are accepted and they may qualify for grant funding to cover their services
 - A. Medicaid covers dental treatment at no cost!
 - B. Kids should be seen by their first birthday at dental offices but most parents are unaware of that. Please encourage parents to make an appointment.
