

Executive Committee Meeting Tuesday, May 23, 2023 Zoom Meeting – 8:00 a.m.

The Executive Committee of the Cabarrus County Partnership for Children met at their scheduled Zoom meeting on Tuesday, May 23, 2023 at 8:00 a.m. by Zoom Meeting. These members were present: Beth Street, Gil Small, and Waynett Taylor. Danielle Mauldin was unable to attend. Beth Street led the meeting with Ann Benfield's assistance because she was driving. Beth welcomed everyone. Staff: Ann Benfield, Ariel Ayers, and Lauren Westin were present. **Quorum was established**.

Ann Benfield presented the minutes of the March 28, 2023 executive committee meeting and the committee reviewed and discussed. Gil Small moved to approve the minutes as presented, and Beth Street seconded and all were in favor.
