


### **Biting**

Due to a few recent biting incidents we've had recently in our county, we reached out to NC Child Care
Health and Safety Resource Center to get a streamlined Biting Policy, below is their response:

I think it will be hard to give "streamline" advice in policy for this as each incident needs to be evaluated on a

case by case basis, per the NC Communicable Disease Branch. They recommend that families should be referred to their child's pediatrician for evaluation and that the pediatricians should be in contact with the health department. If testing was recommended, it would be the role of the Health Director at the HD to re-





Just as an FYI, below are the only mention of "biting in child care" in the NC Communicable Disease Rules.

10A NCAC 41A .0202 Control Measures - HIV

(3) The attending physician of a child who is infected with HIV and who may pose a significant risk of transmission in the school or day care setting because of open, oozing wounds or because of behavioral abnormalities (such as biting) shall notify the local health director. The local health director shall consult with the attending physician and investigate the following circumstances.

10A NCAC 41A .0203 Control Measures - Hepatitis B (e-h)

(e) The attending physician of a child who is infected with hepatitis B virus and who may pose a significant risk of transmission in the school or day care setting because of open, oozing wounds or because of behavioral abnormalities such as biting shall notify the local health director. The local health director shall consult with the attending physician and investigate the circumstances.
